COMMENTS ON UTILISATION OF GRANTS:-

On verification it is observed that a total sum of Rs 1018320.00 has been invested in Canara Bank in shape of FDR out of the available action may be taken to withdraw the invested amount and merged in UGC A/C under intimation to audit. Till then Rs1018320.00 held under objection.
